Who We Are

How We Use Your Personal Data (Legal Basis for Processing)

Elevate Staffing takes your privacy very seriously and will never disclose, sell or share your data without your consent; unless required to do so by law. We only retain your data for as long as is necessary and for the purpose(s) specified in this notice, and you are free to withdraw this consent at any time. *The purposes and reasons for processing your personal data are detailed below: -*

- *We collect and store your personal data as part of our legal obligation for business accounting, payroll and tax purposes;*
- *We collect and store your personal data in order to facilitate the relationship between Organisation and you as an employee of Organisation. For example, Organisation may be required to write to you at your home address or contact you by email should Organisation wish to notify you regarding any changes to the terms and conditions of your employment with Organisation;*
- *For HR purposes including, but not limited to, the instigation of disciplinary procedures, grievance procedures and making changes to the terms and conditions of your employment.*
- *As indicated in your Employment Contract, Organisation may utilise a portrait photo, bio or career profile for business sales purposes and promotion.*

Your Rights

You have the right to access any personal information that Elevate Staffing processes about you and to request information about: -

- The purposes of the processing
- The categories of personal data concerned

- How long we intend to store your personal data for
- If we did not collect the data directly from you, information about the source



If you believe that we hold any incomplete or inaccurate data about you, you have the right to ask us to correct and/or complete the information and we will strive to do so as quickly as possible; unless there is a valid reason for not doing so, at which point you will be notified.

You also have the right to request erasure of your personal data or to restrict processing (*where applicable*) in accordance with the data protection laws; as well as to object to any direct marketing from us. Where applicable, you have the right to data portability of your information and the right to be informed about any automated decision-making we may use.

If we receive a request from you to exercise any of the above rights, we may ask you to verify your identity before acting on the request; this is to ensure that your data is protected and kept secure.

Sharing and Disclosing Your Personal Information

We do not share or disclose any of your personal information without your consent, other than for the purposes specified in this notice or where there is a legal requirement. Elevate Staffing Limited uses third-parties to provide the below services and business functions; however, all processors acting on our behalf only process your data in accordance with instructions from us and comply fully with this privacy notice, the data protection laws and any other appropriate confidentiality and security measures.
